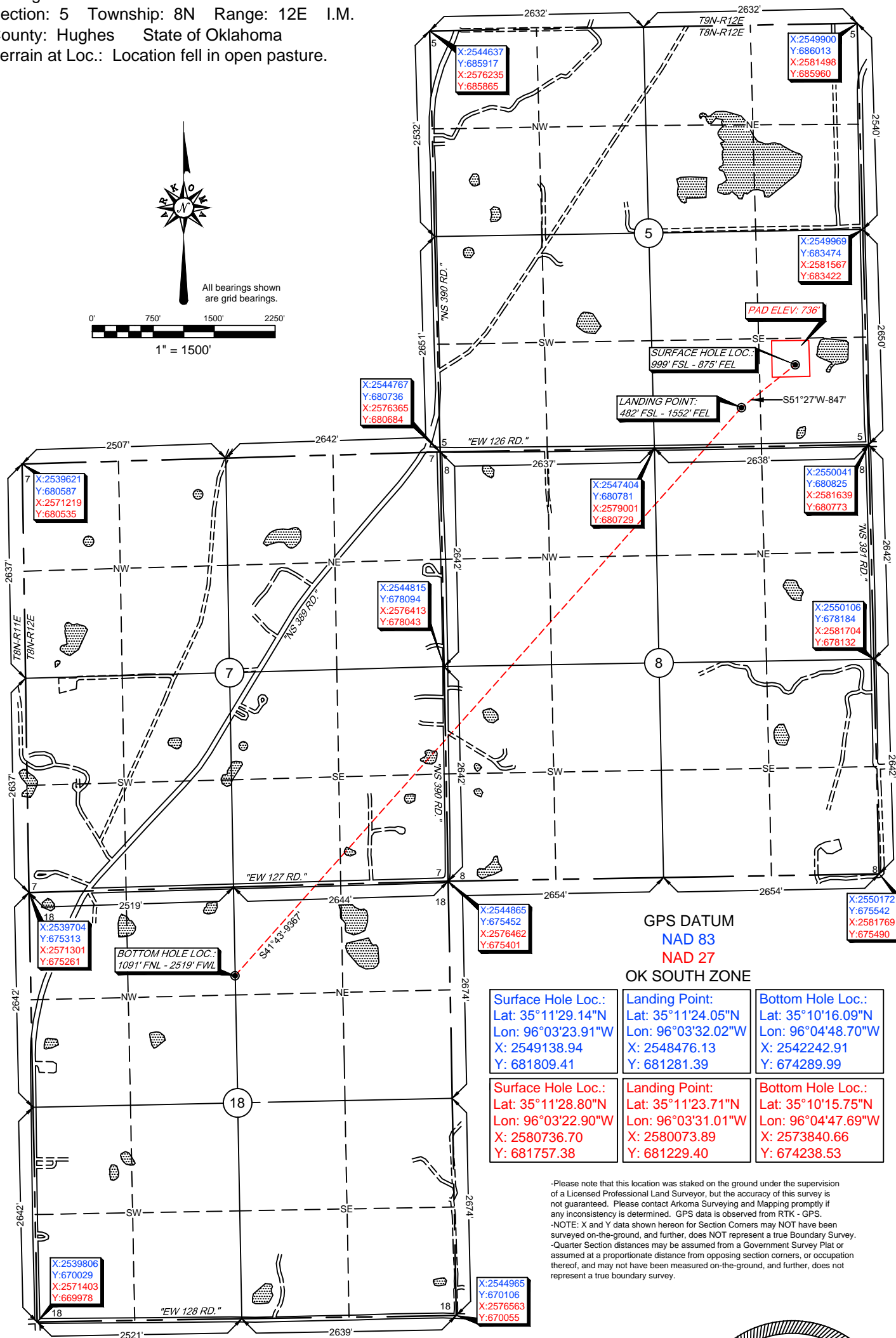


Well Location Plat
