# Well Location Plat

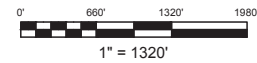

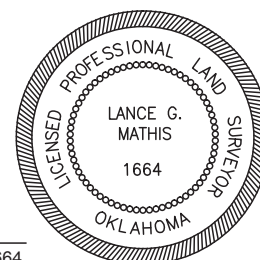
