Dear Mr. Brooks:

We have not received Form 1002A Completion Reports, Form 1002C Cementing Reports, Form 1001A Spud Notices, nor open-hole wireline logs for the above wells, as required by Rules 165:10-3-2, 165:10-3-4(i), 165:10-3-25, and 165:10-3-26. These rules specify that a completion report with an attached cementing report, and well logs, shall be submitted within 60 days after completion of operations, regardless of whether a well is a producer, dry hole, injection, disposal or service well, or a well that was plugged at a later date. A spud notice is also required within 14 days of the well spudding date.

We are requesting that you submit the above Form 1002A Completion Reports, Form 1002C Cementing Reports, Form 1001A Spud Notifications, and well logs within 15 days from the date of receipt of this letter. Well logs must be complete, in one piece, and with complete locations noted. Please submit these forms along with a copy of this letter, marked to the attention of the staff member named in the closing sentence.

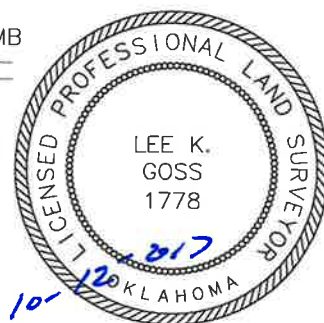

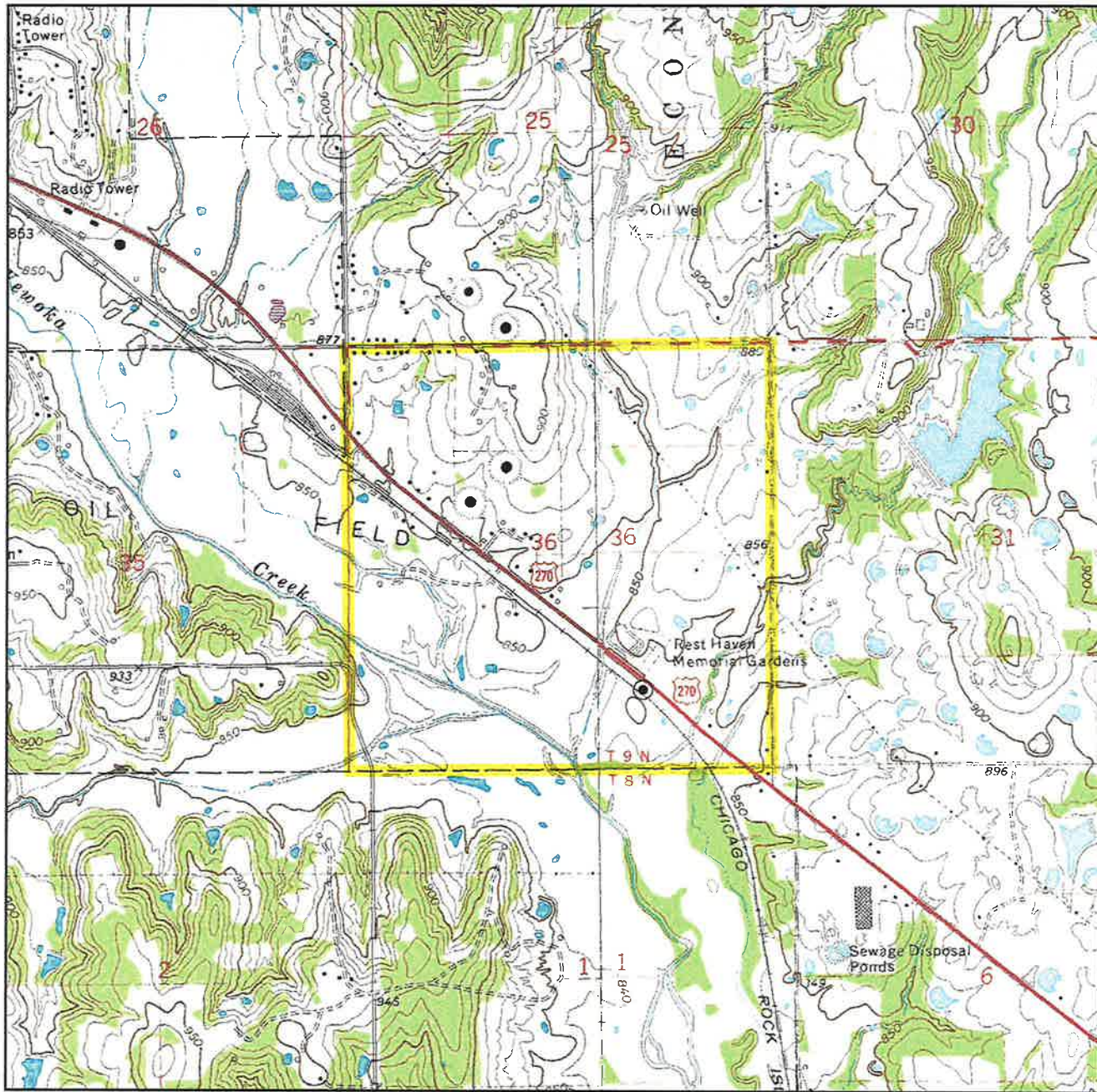
