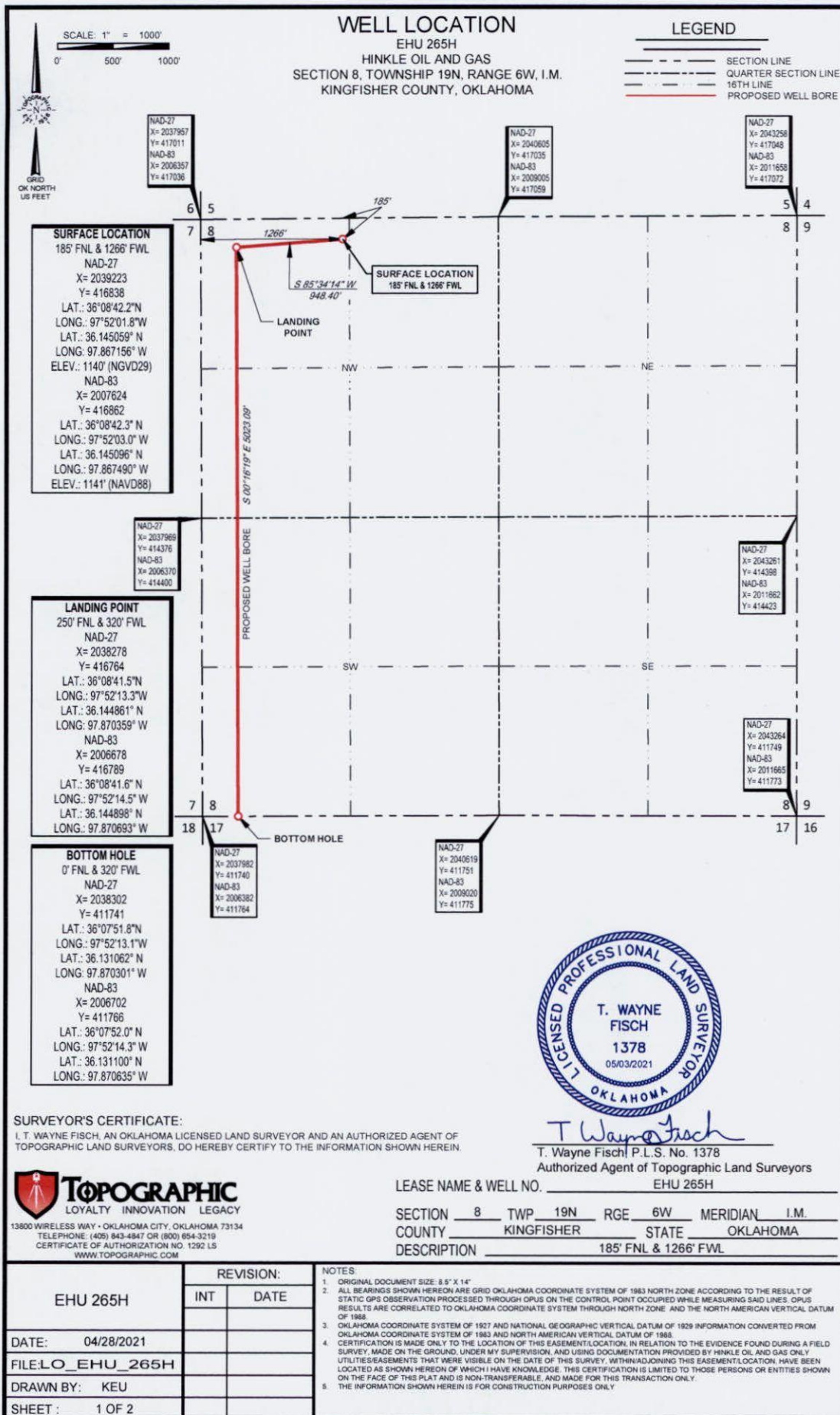

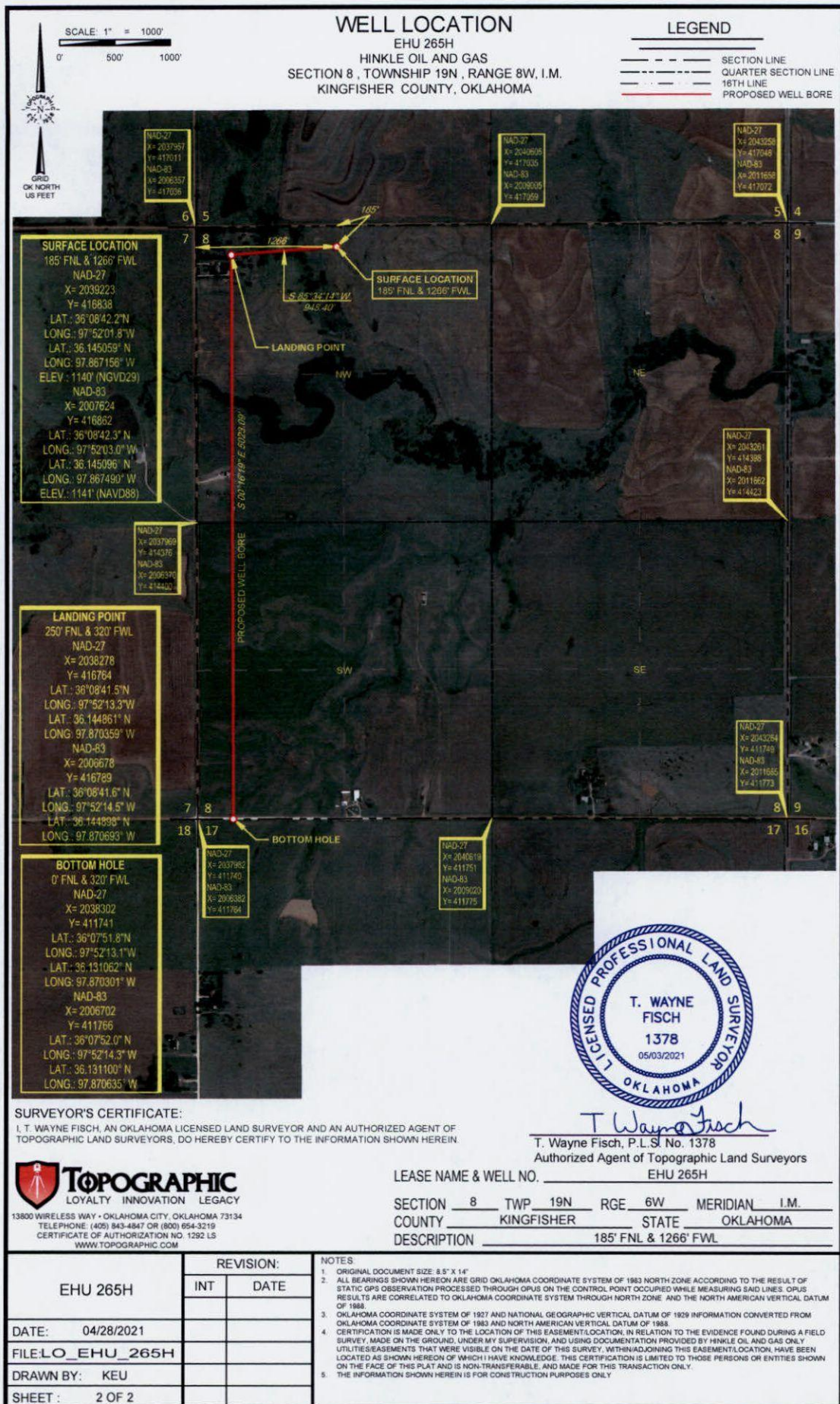

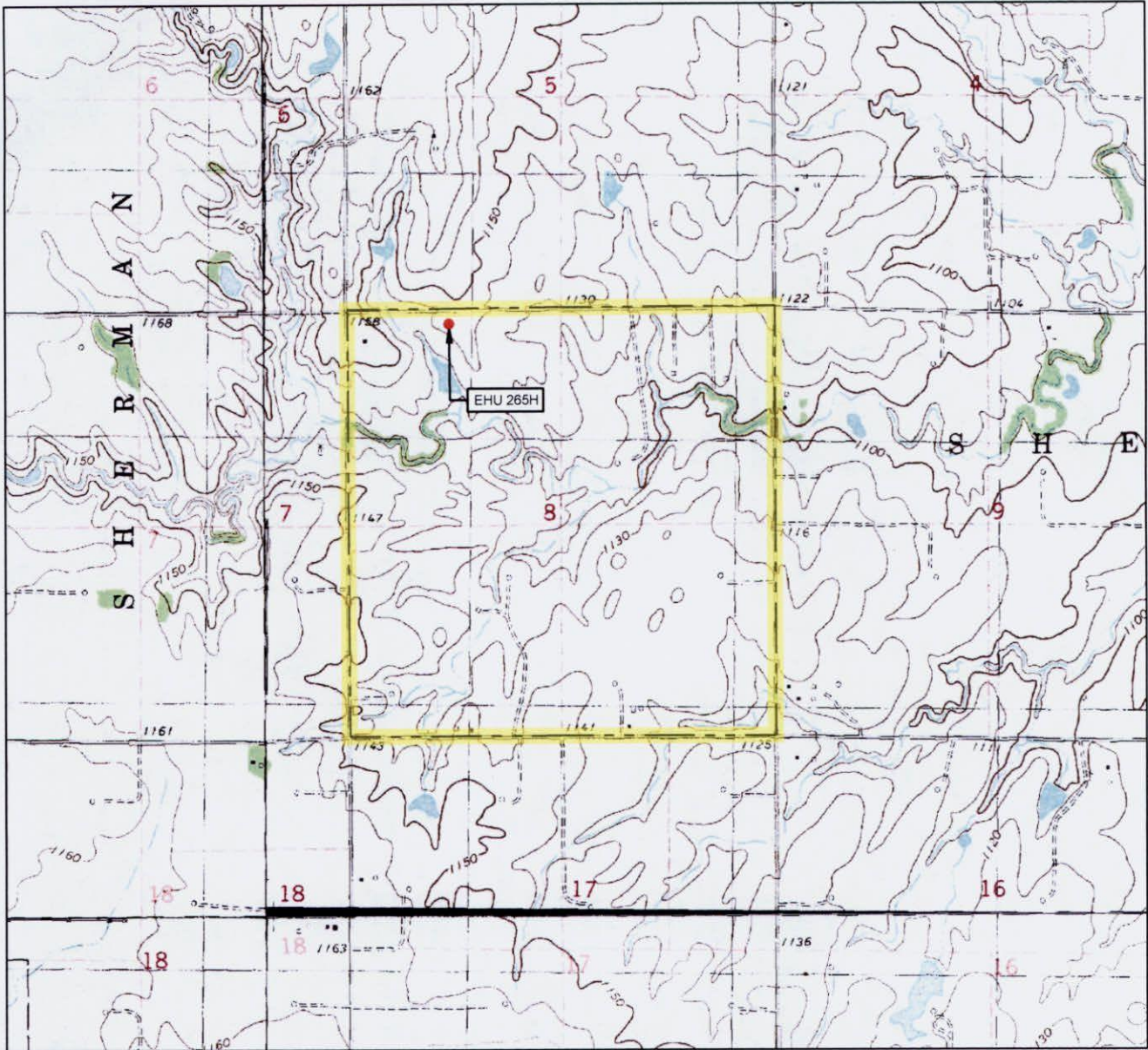








# LOCATION & ELEVATION VERIFICATION MAP

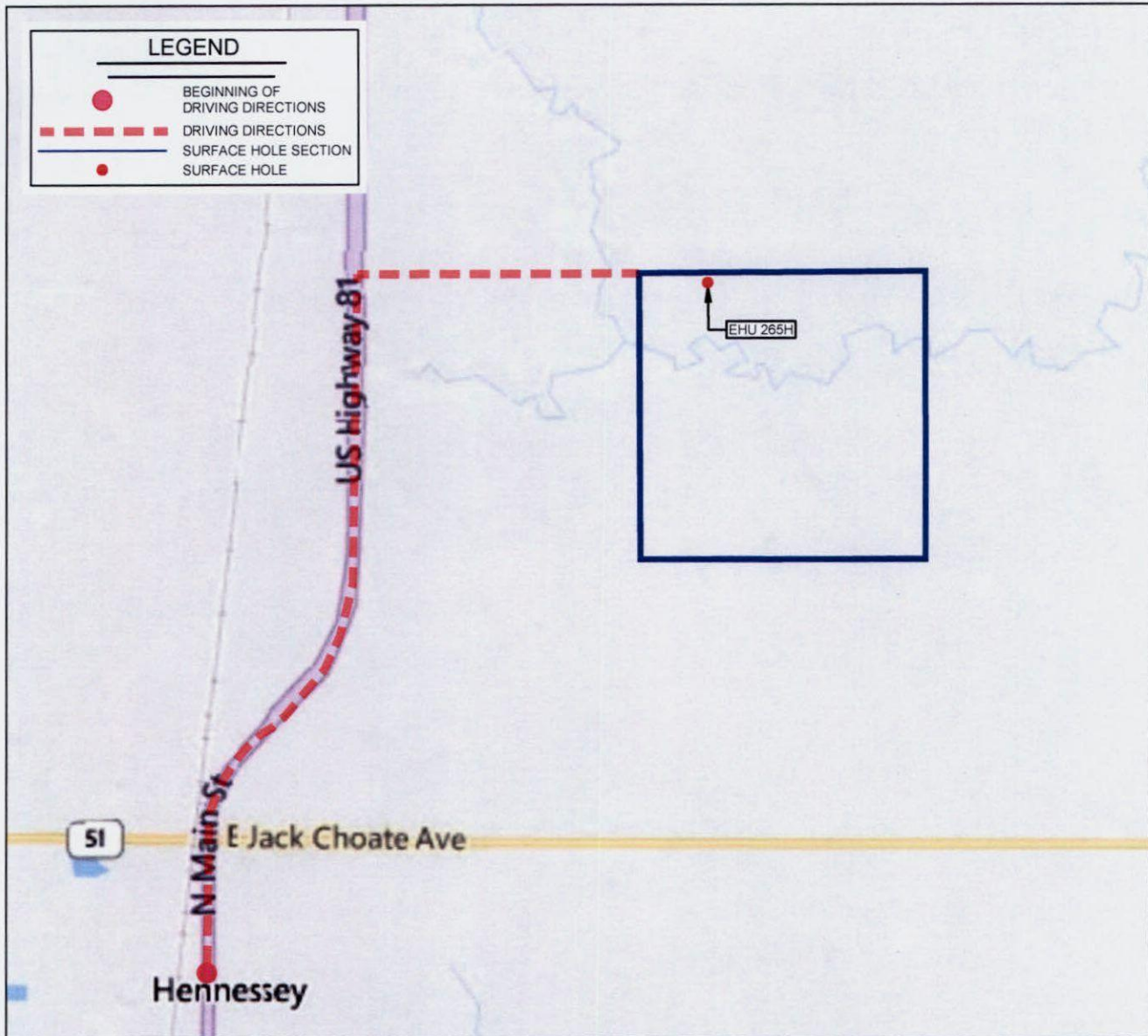
