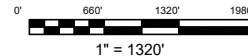
Well Location Plat

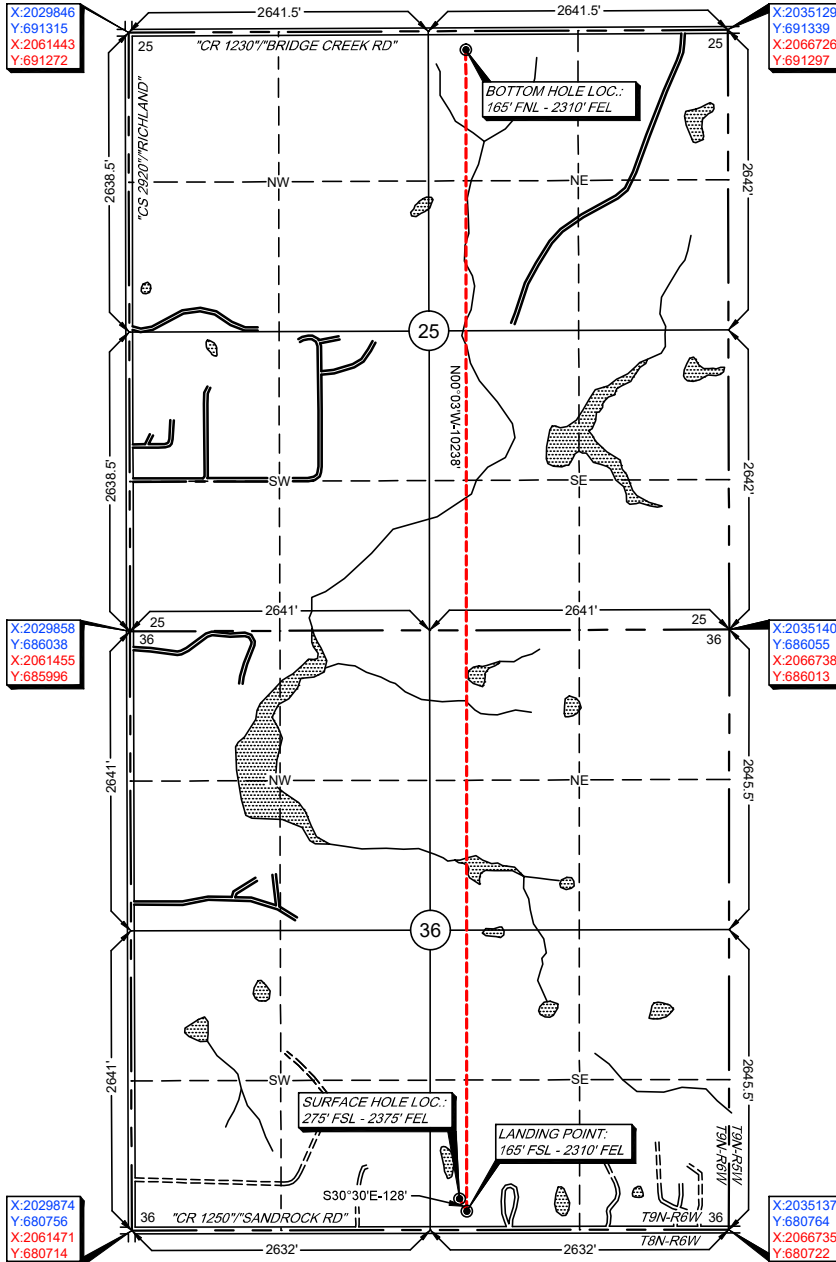

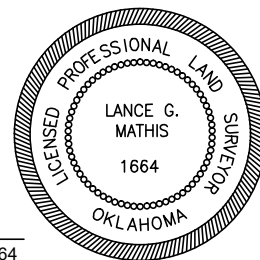

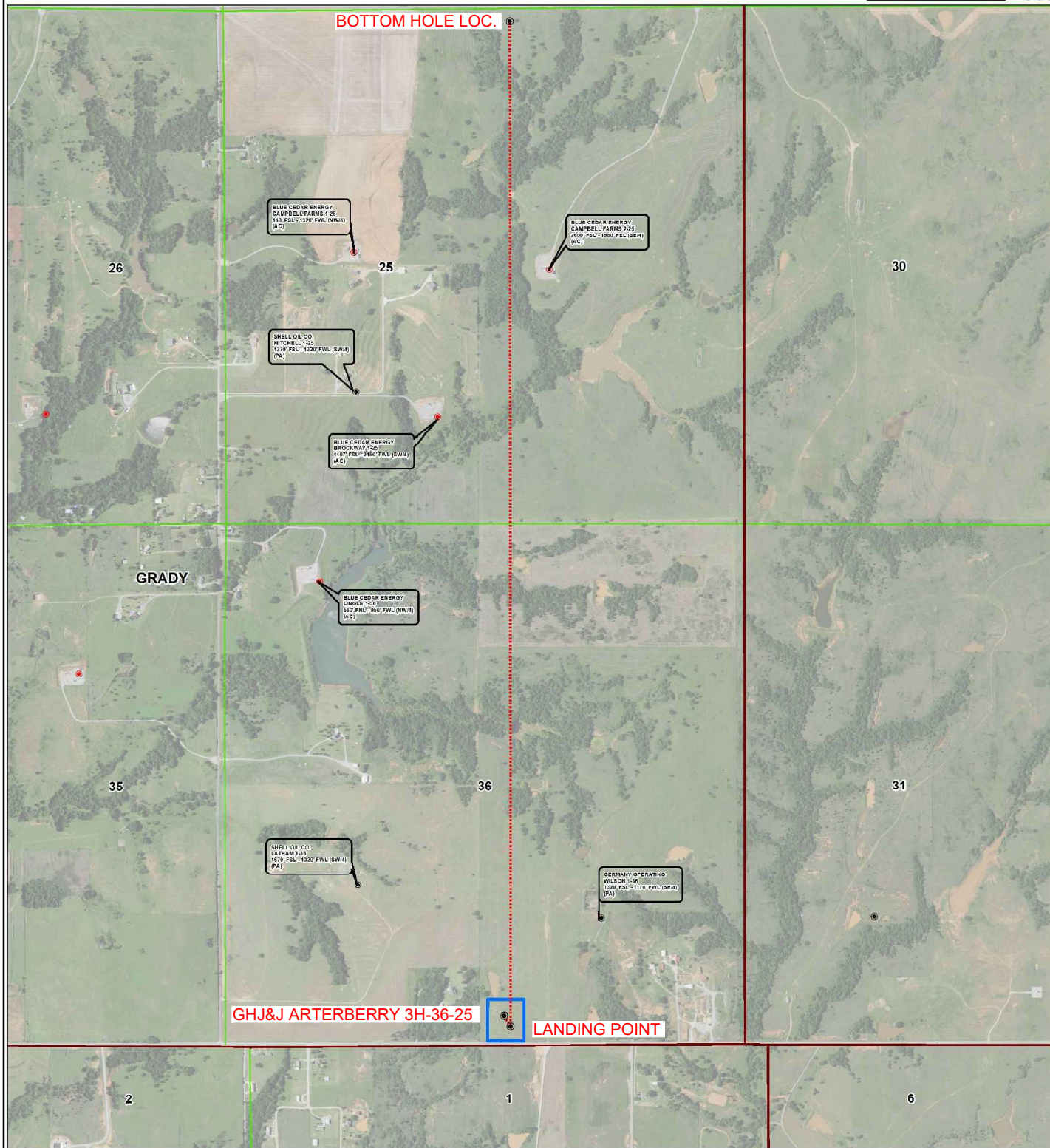

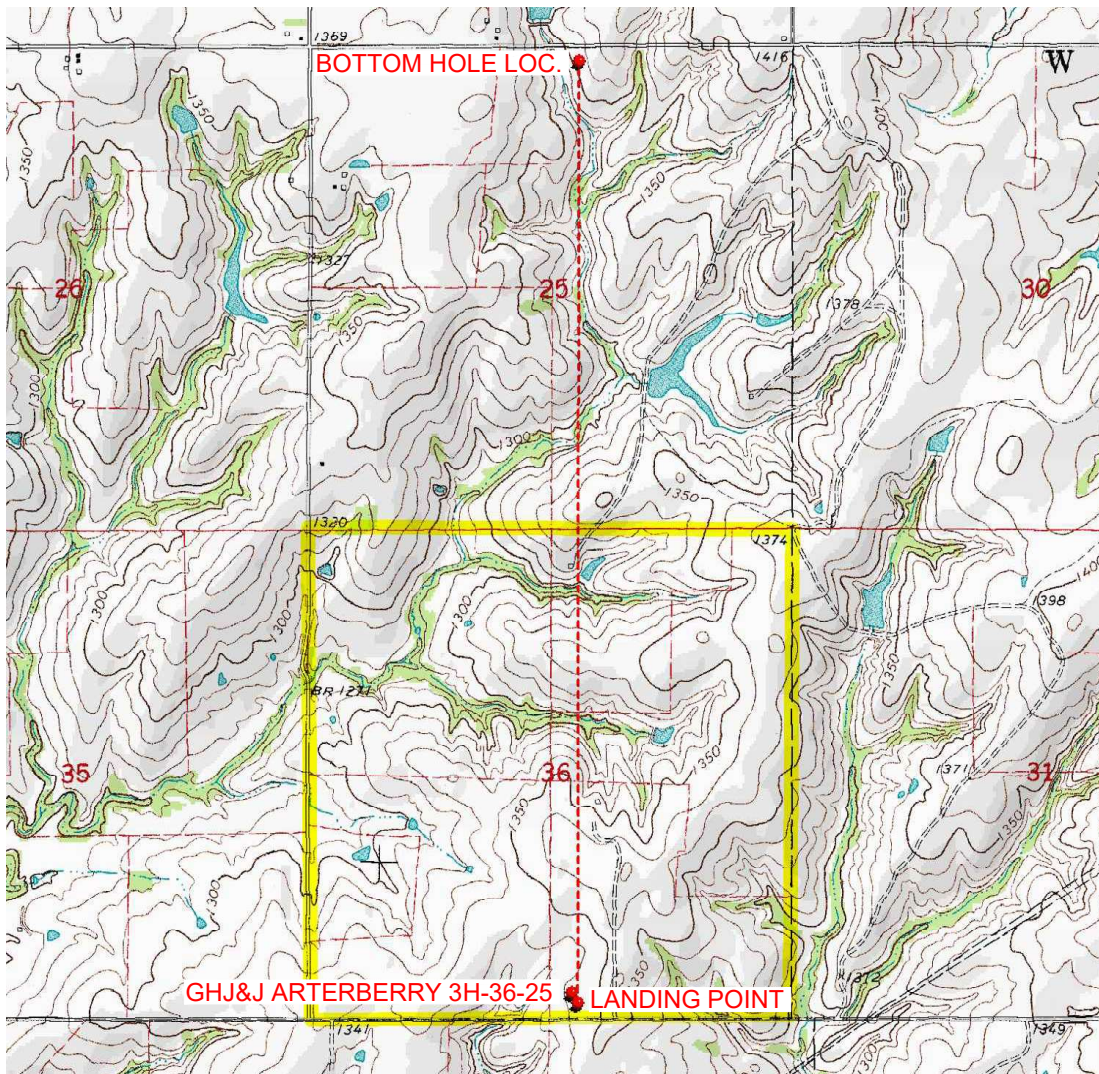
